## Hertfordshire and West Essex Adult Palliative Care Formulary

This formulary has been developed by stakeholders across Hertfordshire and West Essex (HWE) to provide benefits for patients and the local healthcare system as described in NICE Medicines practice guideline MPG1; improving patient care by optimising the use of medicines, supporting the inclusion of patient factors in decisions about medicines, improving quality by reducing inappropriate variations in clinical care, improving quality through access to cost-effective medicines, supporting the supply of medicines across a local health economy, supporting prescribers to follow guidance published by professional regulatory bodies. Healthcare and other professionals are expected to take clinical guidelines and formulary choices fully into account when exercising their clinical judgement. However, this does not override the responsibility of healthcare professionals and others to make decisions appropriate to the circumstances of each patient, in consultation with the patient and/or their guardian or carer.
